UPDATE Leaflet on the new regulations regarding entry into Germany

Dear parents,

Before planned holiday trips we inform you with this leaflet about the new regulations with regards to the entry requirements from abroad into Germany. The recent Corona virus-entry-act regulates from the 1st of August 2021 onward uniformly and nationwide the obligation for registration, attestation and quarantine for all holiday returnees. The regulations are valid for non-risk areas, high-risk areas and virus variant areas alike. "Simple" risk areas do not apply.
